**Yon Irawan Chosen as President Director
of Terminal Petikemas Surabaya**

SURABAYA. The position of President Director of PT Terminal Petikemas Surabaya (TPS), a subsidiary of PT Pelabuhan Indonesia III (Persero) (Pelindo III) which is engaged in the loading and unloading of export and import container officially replaced. President Director of PT TPS previously held by Dothy since 2014 was replaced by Yon Irawan.

M. Solech, Public Relations of PT TPS say the appointment of a new President Directors is common thing does not affect the company's operations that have been run professionally. "Pelindo III as the majority shareholder has taken the decision to replace the President Director of TPS, we appreciate this decision and hopefully can bring TPS powerful with three units new Container Crane (CC) who had come for the business challenges of port, more competitive among other new terminals as TPS competitor," added Solech.

Yon Irawan is not a new member, because he previously served as Corporate Secretary of Pelindo III since 2014 and previously as Senior Manager of Treasury on the financial directorate. TPS Board of Directors at the present time is still William Khoury as vice president director, Nur Syamsiah as Director of Finance, Asma El Moufti as Director of Operations, and Kartiko Adi as Technical Director.

Meanwhile, Dothy also said that changes in the board of directors prevalent in an organization. "It is an dynamics and forward, I believe under the control of a new President Director will be more solid, professional, and remain firm to the company culture in order to ensure the company's targets can be achieved," she said.

PT Terminal Petikemas Surabaya or abbreviated PT TPS is one of the subsidiary companies under Pelindo III Group, engaged in port services in container terminal services export-import and domestic. PT TPS established since 1992 as a unit of Container Terminal (UTPK) and privatized on April 29, 1999 by P & O Dover with a 49% ownership stake. In 2004 PT TPS has achieved throughput of > 1 million TEUs and growing until today. On March 1, 2006 Holding Company P & O Port acquired by DP World, that all assets and investments belonging to P & O Dover shifting ownership to DP World, including a 49% stake in PT TPS so that the composition of the PT TPS is 51% owned by PT Pelindo III and 49% belong to DP World.

PT TPS run core business as an operator of container terminals, as the economic gateway of the export - import region of eastern Indonesia and is the first terminal in Indonesia to implement security standards pelabuhan vessels and facilities that came into effect in July 2004.
